02 Step-by-Step Registration Process.

Step	Action
1	Order: Submit our online Order Form or download and complete the form and send it to us by email or courier.
2	Review & Invoice: Your order is reviewed, the company name availability is checked, and a proforma invoice is issued.
3	Due Diligence: Provide KYC documents for Director(s), Shareholder(s), and Beneficial Owner(s) (passport, proof of address, and other required documents).
4	Payment: Payment is required before incorporation (wire transfer or card payment).
5	Registration: Documents are prepared and filed with the Seychelles Registrar. Incorporation takes 1–2 business days.
6	Documents: You receive the Certificate of Incorporation, Memorandum & Articles, Registers, Share Certificates, and Resolutions.
7	Certification (if needed): Notary and Apostille certification can be arranged (2–4 business days).
8	Delivery: Documents are sent by courier worldwide (1–5 business days).
9	Corporate bank account opening: (2 weeks and more, depending on the chosen bank).

03 Required Documents.



01. Valid passport copy: Original presented in person or certified true copy.



02. Proof of Residential Address: Utility bill or bank statement, issued within the last 3 months, certified true copy.



03. Bank or professional reference letter: Original and dated no later than 3 months old.



04. CV (Curriculum Vitae): Summary of education, experience, and skills.



05. TIN/NIN number: Document evidencing personal Tax Identification/National Insurance Number, certified true copy.

05 Post-Registration Obligations.

- **Annual Government Fee** – Must be paid every year through the Registered Agent.
- **Registered Agent & Address** – Must be maintained and renewed yearly.
- **Professional Fees** – Agent’s service fees are paid annually.
- **Renewal Confirmation** – You must confirm continuation of the company each year.
- **On-Time Payment** – Late payment results in penalties and loss of good standing.

What is a tax haven?

A tax haven is a country offering low or zero taxes, minimal reporting, and strong privacy to attract international businesses.
